Identifying pupils with SEND and assessing their needs

Identification of SEND through referral information, baseline assessment, observation, pupil voice and parental views. The graduated response is used to support planning and delivery of curriculum and learning need specific interventions following the Assess – Plan – Do – Review cycle.

Please see below examples of where adjustments are made to ensure all learners are holistically supported during their journey with us.

Supporting pupils - Adaptive teaching interventions, SEMH support, curriculum adjustments.
 SEMH support, - Trauma-informed approaches, regulation strategies, restorative practice.
 Curriculum and environment - Small groups, flexible pathways, adjusted timetables.
 Parents and pupils - Partnership working and regular communication.
 Transitions - Carefully planned entry, exit and reintegration.
 External agencies - Educational Psychology, SALT, OT, Health and Social Care.
 Staff training - Ongoing SEND and SEMH CPD led by the SENCO.
